

# **STADIUM REGULATIONS**

## **§1**

### **SCOPE OF REGULATIONS**

1. These regulations have been constituted in accordance with provisions of the Act from 20.03.2009 about safety of mass events, referred further as ACT.
2. Regulations are in force at the stadium on st. Pera Jonssona 7.
3. People remaining within the stadium, are the subject to country's law, regulations of both Polish and international sports organizers and the stadium regulations as well.
4. Entering the stadium is equivalent to acceptance of the stadium regulations.
5. Regulations of mass events (stadium regulations) is available for spectators:
  - a) On the board in front of each entrance to the stadium;
  - b) Short version of stadium regulations is printed on each ticket;
  - c) On the official website of the club [www.speedway.torun.pl](http://www.speedway.torun.pl).
6. These regulations include the regulations of mass events organized at the stadium area.

## **§2**

### **STADIUM PURPOSE**

1. Stadium is a place where speedway matches, organized by the Club, are being held.
2. All speedway matches are being held in accordance with the rules and regulations.
3. The club has the right to change the date of each match, which has been already announced, without giving advance notice. The club has no responsibility in this respect.
4. The club does not guarantee the meeting being held in particular date or time.
5. In case of match cancellation there is a possibility to return the ticket and collect the money. There is no possibility to return the ticket upon the match time change.

## **§3**

### **STADIUM ACCESS CONTROL**

1. Decision about who enters the stadium is left to the discretion of the Club's management. Club's management has the right to decide who may enter/need to abandon the stadium. The club's management may authorize third party, especially security service, to make decisions in this respect.
2. The Club may apply a ban on participation in speedway events at the stadium to the person who has not followed the stadium regulations. Appeal procedure is regulated in article 14<sup>th</sup> of the Act.
3. Permission to remain within the Stadium and use the stadium devices is subject to the possession of a valid ticket/speedway pass or any other document which allows for the entrance to the stadium. The valid ID document is required.
4. The security service and staff is authorized (also in use of technical measures) to:
  - a) Check the permissions for entering the stadium;

- b) Check the ID to establish the identity;
  - c) Make a revision of personal things includes bags, clothes etc. in case of suspicion that a person introduces/carries dangerous objects, weapons, explosives, pyrotechnics, fire-risk materials, alcohol beverages, drugs or psychotropic substances;
  - d) Check the permission to remain within the stadium and in case of lack of proper permission to call a person to abandon the stadium immediately;
  - e) Instruct person who disturb public order or does not follow the regulations and if necessary call a person to abandon the stadium immediately;
  - f) Use force, if necessary, in form of self-defense tricks or other defense techniques or use handcuffs and tear gas, in case of goods entrusted to security service or deflect the attack on security service member or any other person, and failure to execute the commands of order in accordance with Article 38 of the Act of 22 August 1997 on Protection of Persons and Property (Journal of Laws No. 114, item 740, as amended);
  - g) Apprehend and hand on to the police a person who poses an immediate threat to life or health and protected property.
5. A person may be refused to enter and remain within the stadium if:
- a) a proper statement has been made by the court, regarding particular person, which does not allow to participate in mass events due to suspension of sentence, crime commitment, imprisonment or regarding adolescent in accordance with art.6 pt. 2 of the Act from 26.10.1982 about the proceedings in juvenile cases;
  - b) has been banned from entering the stadium by authorized entity and this fact has been communicated to the Chief constable;
  - c) has been banned by the club;
  - d) refuses to follow the instruction specified in the §5 of this regulations;
  - e) does not have a document of identity;
  - f) is clearly under the influence of alcohol, drugs, psychotropic substances or other mind-altering substances;
  - g) carries weapon or other dangerous objects, introduces alcohol beverages or mind-altering substances mentioned in §5 of this regulations;
  - h) behaves in aggressive and provocative way or poses a threat to the public order;
  - i) the appearance precludes identification.
6. Persons mentioned in §6 of this regulations are not allowed to enter the stadium or may be requested to leave the stadium and will have no right to request a refund.

#### **§4**

#### **TICKETS TO THE STADIUM (ENTRANCE PASSES)**

1. Entry pass is:
- a) a ticket which determines particular place concerning each event and contains personal data of the spectator, such as name, surname, PESEL; valid only with ID;
  - b) a speedway pass which determines particular place concerning each season or round and contains personal data of the spectator, such as name, surname, PESEL; valid only with ID, valid during the whole season;

- c) accreditation, invitation, identity card, VIP pass issued by the Club's management based on separate regulations, valid only with ID.
2. The ticket and the speedway pass – documents which allows to enter the stadium for the sport event are valid only on presentation of an identity document.
3. Ticket purchase is carried out at ticket offices around the stadium or at others sales points appointed by the Club. Entry pass cannot be sold to:
  - a) a person who has been banned, by court, from entering mass events, due to suspension of sentence, crime commitment, imprisonment or regarding adolescent in accordance with art.6 pt. 2 of the Act from 26.10.1982 about the proceedings in juvenile cases;
  - b) a person who has been banned by, authorized entity, from entering the stadium and this fact has been communicated to the Chief constable;
  - c) a person who has been banned by the club.
4. The person entering the stadium is required to present the ticket or speedway pass and the ID as well. Personal data contained on the ticket/speedway pass must be compliant with ID data.
5. Spectators are required to take their seats which are determined on the ticket/speedway pass in accordance with specific numbering. Move only if needed. Not following the instruction above may cause ban.
6. Person who is allowed to enter the Stadium (accredited, invited, journalists, VIPs) is required to use the entrance appointed by the club.
7. Person who has the entrance free of charge is required to take the seat appointed by the club.
8. Tickets, speedway passes and other entry passes must be retained for inspection during whole event until leaving the stadium. Club has the right to call a person to abandon the stadium if is not able to present the ticket, speedway pass or other entry pass during the event.
9. Ticket purchase for fans of opposing team is carried out by their club.
10. Club's management may require from opponent club the affirmation, sent to the club's office 7 days before the event , which informs about amount of spectators, date and place of their arrival, under pain of lack of consent to enter the stadium.

## **§5**

### **BEHAVIOR AT THE STADIUM**

1. Everyone who remains within the Stadium shall behave in a way which has no bad influence on the others and does not pose a threat.
2. Everyone who remains within the Stadium is required do follow the instruction given by fire brigade, security service, staff, announcer, Police and military police.
3. Anyone who does not follow the instructions based on Act, stadium regulations or mass event regulations, given by security service or staff, will be subject to a penalty of 2000 PLN and the penalty of 2000 PLN imposed by the Club in accordance with this regulations.

4. Anyone who does not follow the instructions given by the Police or military police during the event will be subject to a penalty of 2000 PLN and the penalty of 2000 PLN imposed by the Club in accordance with this regulations.
5. Spectators are required to take their seats which are determined on their tickets unless other instruction has been given by the relevant entities.
6. Spectators are required to remain within the zone designated for audience.
7. Anyone who remains within the zone which is not designated for audience will be subject to a penalty of 2000 PLN and the penalty of 2000 PLN imposed by the Club in accordance with this regulations.
8. Spectators are not allowed to bring and disseminate marketing materials at the Stadium unless they get the approval from the Club, under pain of penalty of 1000 PLN in accordance with this regulations.
9. Spectators are not allowed to sell and disseminate any goods, tickets, publications, printings and whip-rounds unless they get the approval from the Club, under pain of penalty of 1000 PLN in accordance with this regulations.
10. Spectators are not allowed to use any electronic devices which can record, process and transmit the event unless they get the approval from the Club, under pain of penalty of 2000 PLN in accordance with this regulations.
11. The Club is not responsible for the personal belongings left at the Stadium.
12. Ticket does not entitle the ticket holder to re-enter the stadium if he left the stadium during the event.
13. Any emergency exits, emergency routes etc. shall be kept released.

## **§6 PROHIBITIONS**

1. It is forbidden to bring and own at the stadium area:
  - a) Alcohol beverages – anyone who introduces and carries alcohol beverages on the mass event is a subject to a penalty of 2000 PLN and the penalty of 2000 PLN imposed by the Club in accordance with this regulations;
  - b) Glass and plastic bottles, cans, tear gas container, corrosives, weapons in the light of the Act from 21.05.1990 about weapons and ammunitions, pyrotechnics, fire-risk materials and any other dangerous measures or explosives – anyone who carries or introduces weapons (defined in the Act from 21.05.1990 about weapons and ammunitions), pyrotechnics, fire-risk materials or other dangerous objects or explosives to the mass event will be subject to a penalty of daily rate times 180, restriction of liberty or imprisonment of 3 months - 5 years and penalty of 5000 PLN imposed by the Club in accordance with this regulations;
  - c) Narcotic drugs or psychotropic substances – anyone who carries or introduces narcotic drugs or psychotropic substances to the mass event will be subject to a penalty of the club ban for period of minimum 6 months from the time of issue and penalty of 5000 PLN imposed by the Club in accordance with this regulations.
2. More over it is forbidden to:
  - a) Move between sectors without the approval of security service or the authorized entities;

- b) Encroach on the infield area/stadium during the event and ignore the instruction of the security service to leave the infield area/stadium – anyone who encroach on the area where speedway matches/sports games are being held and ignores the instruction of the security service to leave this area will be subject to a penalty of daily rate times 180, restriction of liberty or imprisonment of up to 3 years and penalty of 2000 PLN imposed by the Club in accordance with this regulations;
  - c) Throw any objects to the pitch area – anyone who throws objects to the pitch area, during the event, which may poses a threat for life, health or violate safety or interferes with the course of event, will be subject to a penalty of daily rate times 120, restriction of liberty or imprisonment of up to 2 years and penalty of 2000 PLN imposed by the Club in accordance with this regulations;
  - d) Kindle fire, use fireworks, flares, glowing balls;
  - e) Battery against the member of security service or information service – anyone who use the force against security service or information service will be subject to a penalty of daily rate times 120, restriction of liberty or imprisonment of up to 2 years and penalty of 5000 PLN imposed by the Club in accordance with this regulations;
  - f) Covering the face using elements of clothing in order to prevent from identification while committing a criminal offence – anyone who commits a criminal offence and use elements of clothing to cover the face in order to prevent from identification will be subject to a penalty of daily rate times 240, restriction of liberty or imprisonment of 3 months - 5 years and penalty of 2000 PLN imposed by the Club in accordance with this regulations;
  - g) Using profanity, sing offensive songs, insulting people, hanging flags and banners with derogatory subtitles. In case of not following this instructions the Club imposes penalty of 1000 PLN in accordance with this regulations;
  - h) Entering the areas for the staff only, for instance pitch area, club rooms, staff only rooms;
  - i) Climbing fences, walls, barriers, balustrades etc. In case of not following this instructions the Club imposes penalty of 1000 PLN in accordance with this regulations;
  - j) Satisfying physiological needs at other places than toilets, dropping the litter. In case of not following this instructions the Club imposes penalty of 1000 PLN in accordance with this regulations.
3. It is forbidden to remain within the Stadium while drunk before, during and after the event, under pain of penalty.
  4. Dangerous objects, alcohol beverages, pyrotechnics, narcotic drugs found by security service during revision will be secured and transferred to law-enforcement agencies for their request.
  5. Any mechanical, electrical vehicles and bikes cannot enter the stadium without Club's approval.
  6. Any vehicles parked at the Stadium area without a proper permission issued by the Club will be removed from the Stadium area and towed away to the parking for the owner's cost.

## **§7**

### **MEDIA REPRESENTATIVES**

1. Press, radio and TV representatives may remain within the Stadium provided that they have a valid press pass and accreditation card issued by the Club's management. Media representatives are required to wear identification cards and it must be visible for the staff and security service.
2. Media representatives may transmit and record sound and image during the event only if they obtain written consent.
3. If not following the instruction mentioned in pt 2., media representatives will be expelled from the Stadium and will be call to deliver devices with recorded materiall.

## **§8**

### **SECURITY SERVICE**

1. Organizer service should have IDs defining function exercised at the stadium,
2. Organizer service consists of:
  - a) Organization service;
  - b) Technical service;
  - c) Medical service;
  - d) Security service;
  - e) Information service.
3. Members of security service are entitled to operate in accordance with §3 and §4 of this regulations and should have IDs with inscription "Security service" and contain information such as name of entity which issued the id, identification number, photo, stamp and signature of entity which issued the id. Club issues identifiers for:
  - a) Media representatives who received accreditations;
  - b) TV broadcasting staff;
  - c) Communication service.

## **§9**

### **INFORMATION SERVICE**

1. In order to increase the comfort of people participating in the event organized on the Stadium, the Club provides assistance for information service
2. Information service is obligated to:
  - a) Inform about facilities and security requirements defined by the Club and emergency service;
  - b) Inform about the location of medical points, catering and refreshments, sanitary points;
  - c) Oversee safety at the entrance and exit during the event organized at the Stadium;
  - d) Ward off people trying to enter sectors which are not designated for spectators;
  - e) React to incidents immediately and poses of threat and take necessary actions;
  - f) Tend the compliance of this regulations;
  - g) React to complaints reported by the spectators.

**§10**  
**RESPONSIBILITY**

1. Persons violating the rules of safety and order bear responsibility in light of administrative and criminal law.
2. Persons causing damages to property are required to remedy them.
3. The Club is obligated to expel every person, from the stadium, who does not follow the regulations, especially §6 or safety rules or may pose a threat in relation to other people. Expelled person has no right to reimbursement.
4. A person, who is particularly burdensome, may be banned by the Club and has no right to enter the Stadium.

**§11**  
**THE RECORD OF THE EVENT**

1. The Club is authorized to record course of event , in particular, audience behavior, by sound and image recording devices.

**§12**  
**ORGANIZATION OF MATCH FIXTURES**

1. Group of fans, which is interested to prepare a match fixture during the event should report to the Club before each event in order to adjust contents and conditions of the match fixtures. The Group should receive a proper identifiers.
2. In accordance with the Act it is forbidden to
  - a) Provide any political activities;
  - b) Exhibit banners, flags etc. which belong to any political parties;
  - c) Exhibit banners, flags etc. which promote racial abuse or present fascist or totalitarian contents;
  - d) Other which call for intolerance, chauvinism, xenophobia, hooliganism or present vulgar contents and call for aggressive behavior;
  - e) Exhibit banner, flags etc. which insult the Club or its representatives;
  - f) Cover commercial banners, which have been sold to sponsors.
